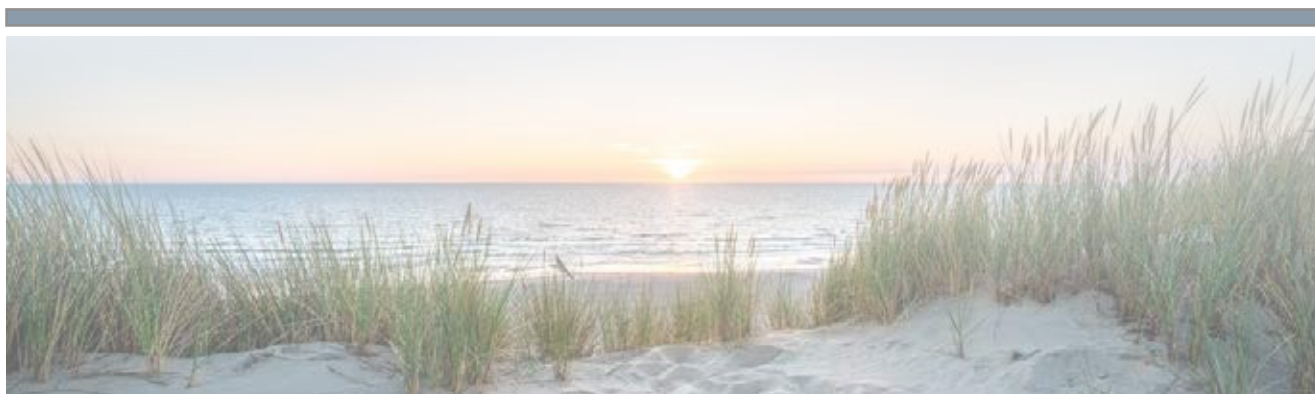
What my clients say
